Chair Report	Hello Family,  I sent the information for the October RSC to the webmaster to post on line.

	<p>Since our April meeting I have been wondering if we are all here for the same reason. Our minutes are micro managed and when there is an issues its keep quiet until 15 minutes before our June RSC .Too late to do any research. The right answer to the motion according to Robert’s rules of order, was that all motions that go against policy is null and void immediately. This would have saved some time and resentments.</p> <p>Four areas from our region hosted the ECCNA that raises money to buy basic text for prisons. I attended the convention with a recovering addict .It was awesome the way they did the convention .The main speaker meeting was broadcasted live to eight prisons in the state and the way they did the clean time countdown was really moving .It was the first time this was done and could be something done all the time at the ECCNA. It was great to be a part of this and I couldn’t stop talking about for a while.</p> <p>In Loving Service Jim H.</p>
Vice Chair Report	<p>I chaired the last RSC and thoroughly the experience. The RSC seemed to go fine and I had no objections to my handing of the meeting. Other than that, I have nothing further to report.</p> <p>ILS, Bill M.</p>
Secretary Report	<p>All is well, thanks for the opportunity to serve.</p> <p>ILS, Brian C.</p>
Treasurer Report	<p>All the bills that I know of up to today are paid. We had a balance of \$16,548.44 at the 168th RSC. Since then we have deposited \$940.92 (\$37.00 was a correction for a math error). We have had debits totaling \$2795.53 to give us a current balance of \$14,693.83. Checks 1167, 1173, and 1176 are still out. I paid Primus and PCMS since the bank statement was issued so our actual balance doesn’t match the bank statement associated with this report.</p> <p>Our YTD (2014) expenses have been \$10,590.14 and our YTD income has been \$12,294.75. We sent a contribution to NAWS for \$1,271.44.</p> <p>The three checks that have not come through the bank yet are a bit disconcerting. Check 1167 was for \$300 and was written to NAWS to help defray the cost to the WSO for sending a representative to the AZF. I’ve contacted WSO and they don’t think that they ever got the check. Check 1173 was to the Massey Foundation and it should be coming in soon. A trusted servant put the check in their wallet and forgot to send it in. Check 1176 was written to the UVA Hospital Auxillary and was replacing a previous check that never showed up. It covers the cost of three RSC’s. these checks might have been passed around in the mail to get a second signature so I need everyone who is a signaturor to look around their house to make sure that the checks haven’t been accidently tucked away somewhere.</p> <p>Our prudent reserve as determined by the formula approved by the RCMs is \$15,277.00. If we subtract this from our current actual balance the difference is \$-583.17. We are under the prudent reserve so no contribution will be sent to NAWS.</p> <p>ILS,</p>

RDA Report	<p>Hello family,</p> <p>I would first like to once again extend an apology for my absence here at the RSC in June. Though it marks my only absence at an RSC due to a scheduling conflict (a planned vacation), I acknowledge that being absent at the first RSC to follow the World Service Conference was regrettable to say the least. I am grateful to our secretary for his service in taking on the daunting task of reading my report so that it could be included in the minutes (thank you Brian).</p> <p>On Friday July 25th Kim A. and I drove together to the Autonomy Zonal Forum in Fairmont, WV (hosted by the Mountaineer Region). All six regions that comprise the AZF were present. In the interest of time (as with the previous AZF in January) the facilitator announced we would dispense with the reading of reports and simply include them in the minutes (which can be found by going to <a href="http://automyzonalforum.org">"automyzonalforum.org"</a>). The entire AZF focused on the development of the AZF website, and the creation/utilization of a discussion board and conference call to develop a vision/mission statement (or put simply: where we want to go – and how we plan to get there) Kim A.'s report will cover all that transpired regarding the AZF. One item her report may not cover however was a request that was made regarding the upcoming AVCNA33 in January. The Autonomy Zone Forum has asked for a workshop slot at our annual regional convention to help spread awareness about the AZF, and its function. I spoke with James S. (Program Chair for AVCNA33) about the possibility of the Autonomy Zone utilizing our regional slot that's typically set aside on Saturday morning and he was very receptive. I said that I would bring it to this body under open forum/new business to see if we might agree.</p> <p>I am submitting a single gas receipt in the amount of \$50.00, and two food receipts totaling \$22.65 for reimbursement (for a total of \$72.65).</p> <p>As some of you may know Donna Lee P. is no longer serving as our Regional Delegate. For those who were unaware, I encourage you to call her to extend your love and support, and to join with me in expressing your appreciation for her service to this</p>

	<p>body over the past five plus years. I wish to express my sincere and heartfelt gratitude for the guidance and mentorship she's provided myself and Kim A. while serving this body by her side.</p> <p>Given this recent development, I believe that all Delegate team positions should be sent back to groups today for nominations at the October RSC for the following reason:</p> <p>Given that the RD position is currently vacant I believe (according to Policy) that it should be sent back to groups for nominations with myself as an automatic nominee. If there are no new nominations for RD in October, nominations would then be closed and my name would be sent back as the sole nominee for a vote in December.</p> <p>Likewise, due to an almost certainty of being elected as RD in December (vacating the RDA position), I believe that nominations for the RDA position should also be sent back to groups for nominations today (with our RDA2 Kim A. as an automatic nominee). If there are no new nominations for RDA in October, nominations would likewise be closed and her name would also be sent back as the sole nominee for a vote at the December RSC. Again, with the likelihood of Kim A. being elected RDA in December (effectively vacating the RDA2 position) I believe that RDA2 should be sent back to groups for nominations today.</p> <p>To be in keeping with our policy that states: "trusted servants should announce two RSC's prior to their positions becoming vacant"</p> <p>Regarding the upcoming two day in October:</p> <p>For at least the past three years (even further back if I'm not mistaken) the Delegate Team has accepted the task of facilitating the second day of the two day regional meetings in October. Typically by the August RSC we would have determined the agenda, worked up a flier and brought copies to be distributed here today. Gratefully (without being asked) our Regional Chair Jim H. has taken the initiative to develop the agenda for the upcoming two day. Once the agenda is finalized we will create a flyer to be posted to the regional website.</p> <p>In Loving Service, Eddie W. (RDA)</p>
RDA2 Report	<p>I attended the Autonomy Zonal Forum hosted by the Mountaineer Region with Eddie on July 27th, 2014. The minutes from this event are available on <a href="http://autonomyzonalforum.org">http://autonomyzonalforum.org</a>. Eddie and I discussed how best to not duplicate each other's information in our reports and decided that I would report on the AZF Website Information and the decisions we made that related specifically to the website.</p> <p>We began our day with presentations from myself and Sherry V during which we each showed the members of the AZF some map ideas we had worked on for the homepage of our website. A decision was made to implement one of them and it can now be viewed on <a href="http://autonomyzonalforum.org">http://autonomyzonalforum.org</a>. I will be working on a new word press website design to present in January when we meet again. We agreed that we wanted to continue with the new domain name <a href="http://autonomyzonalforum.org">autonomyzonalforum.org</a> and that for the time being that domain would be hosted through <a href="http://webmastery.org">webmastery.org</a>. For total transparency, information was again relayed to the body concerning the fact that the domain is registered to the Autonomy Zonal Forum and is not in any one addict's name. The account for the hosting is likewise not in any one addict's name. The usernames and passwords are all on record with Merle S (acting secretary). We discussed which links we would like to include in the new website design and this will be discussed further during the upcoming phone conference.</p>

Further discussions concerned how we will implement the goals we came up with in 2013 after our Zonal Inventory. We decided we will need a vision and mission statement and that it would be useful to gather our ideas together on a discussion board on our website and then discuss these ideas during a conference call October 20th at 9:30 pm. We made the decision that it would be useful to have this discussion board password protected and on August 1st it went live. The usernames and passwords for all the conference participants and interested members were generated and sent out.

The AZF is continuing our forward momentum and becoming increasingly involved with seeking out opportunities for mentorship throughout our zone and the sharing of information directly impacting our fellowship.

Merle (EPARNA) agreed to assist Steve (FREESTATE) in a workshop at the Free State Convention. Zoe (GREATER PHILLY) asked for a volunteer to help her do a workshop at the Greater Philly convention August 22nd – August 24th, 2014. We do anticipate being able to participate in more events throughout our zone in the future. The next Zonal Forum will take place in the Chesapeake and Potomac Region on January 31, 2015. More information will be posted on the AZF website as it becomes available.

Another decision the body made was to have a website calendar which I was able to put up on the website on August 3, 2014. We chose to implement a Google Calendar, which is very easy to update and maintain as well as being extremely user friendly. In regards to my duties as our Region's Web Servant to NAWs I emailed a request to each RCM asking you to either confirm your website meeting information is accurate or to send me a copy of your most current meeting list. I do want to thank Robert from New Dominion for his lone response. I feel there is no point in me cross checking the information available on each of your websites with what World Services has without knowing that your website information is current. I am open to some clear direction from this body on how I should proceed.

I would like to take this opportunity to emphasize the importance of every group updating world services with their meeting information. World Services has two forms for us to use with regards to making sure that addicts trying to find a meeting are given accurate information. I am including three links in this report and cannot stress enough the importance of making sure all of our groups receive this information. Have you ever been on vacation and tried to find a meeting and ended up having a local phone line or the World Services Meeting App send you to a building in a seedy part of town where the only addicts you could find were using ones? We might want to consider putting these forms on our area websites and or on our regional website.

H&I Chair Report	<p>Hello all,</p> <p>I would first like to thank the body for its patience as my personal and professional commitments have taken priority this summer. I was unable to attend the last meeting of CARNA because of professional obligations. I was also unable to attend the last Subcommittee meetings because of personal commitments that could not be compromised.</p> <p>The CARNA H&amp;I Subcommittee, led by Nancy H. in my absence (report attached), met on Saturday, July 19, 2014 at the CP Jones Memorial Library, 406 W Riverside St, Covington, VA. There were 7 trusted servants in attendance and we had no call ins for the teleconference. The meeting was opened with the reading of the 12 traditions and concepts followed by the Serenity Prayer.</p> <p>Bullet 1 – We hold regularly scheduled meetings every other month and follow the quadrant rotation as prescribed in the subject service handbook. We have secured and accounted for the CARNA H&amp;I literature inventory. I have received no letters from inmates in the past 3 months.</p> <p>Bullet 2 – We have gathered and continue to gather information on existing commitments within the region. We are also working on a list of potential commitments.</p> <p>Bullet 3 – We were approached via the WSC about contacting Indian Creek Correctional Facility about the possibility of serving their inmates. Tidewater Area H&amp;I has been contacted and we are waiting to hear from the facility.</p> <p>Bullet 4 – We were asked by Southside Area to hold a training day. We will work to satisfy this request by the next Regional Conference</p> <p>Bullet 5 – We attend the NAWS H&amp;I web conferences on a quarterly basis and remain apprised of upcoming events and training within the NA community. The biggest effort from NAWS H&amp;I/PR is to reach out to as many facilities as possible for the 2015 unity day in Rio de Janeiro, Brazil.</p> <p>Bullet 6 – Refer to bullet 3</p> <p>Bullet 7 – RCMS, please include information on H&amp;I within your areas in your monthly reports.</p> <p>Also please inform your areas of the phone in option for attendance to regional sub-committee meetings.</p> <p>Bullet 8 – The Subcommittee has been trying to work on this effort for over 3 years. It was decided at the March Subcommittee meeting held in Lady Smith, VA that we would hold regularly scheduled teleconferences to make progress on this effort. Through these teleconferences we have finalized a policy, begun organizing a roll out package and developed a plan to reach out to areas. These teleconferences were made available to anyone that wished to attend and communicated through CARNA Meetings and the CARNA H&amp;I contact lists. I do understand some members had scheduling conflicts and are unable to attend. The work that has been completed was</p>

done in the spirit of accountability to the CARNA H&I Subcommittee policy that was in place prior to my nomination. This H&I Subcommittee policy states that we are to have an Inmate Step Writing effort.

It is clear that resources at CARNA are strained, while the resources at the CARNA Subcommittee level are strained even further. The H&I subcommittee decided, in my absence, that the committee does not have the resources to support the ISW effort. The Subcommittee decided, based on this, that a new service commitment was not practical at this time. I believe this can be cleared up with my presence at the next Subcommittee meeting and sharing the work that has been completed by the ISW work group up to this point.

[Further, this effort and the challenges it presents, brings to surface some valid cultural issues within the region. This Subcommittee needs direction from the RCMs of this body as to what services their areas require of the region. Do the RCMs want the region to provide tangible service directly to addicts or do the RCMs want the regional Subcommittees to serve as primarily trainers and/or facilitators for their service efforts? It is my understanding that the Subcommittee cannot decide what services it will or will not provide. The Subcommittee serves at the pleasure of the body and is here to fulfill all requests from the body. I would like clarification on this from the body.] – Asked in open forum and clarified by members present.

In Open Forum today the members present stated that regional sub committees should both provide services to addicts that are not being served by Areas and support areas in their service efforts. Also, the current Vice Chair of CARNA clarified that Subcommittees have the autonomy to write their own policy and provide services as that body seems fit.

Upcoming service opportunities for this body include:

Working with institutions to live stream meetings into facilities that cannot attend regular meetings and don't currently have H&I commitments

Work with facilities to offer upcoming Unity Day Meeting at the next WCNA in Rio De Janeiro Brazil, June 2015

Work with Indian Creek Correctional Facility for support of existing NA commitment

Work with Almost Heaven Area on correspondence and possible one time meeting at a Federal facility that borders with Gateway to Freedom Area

At the next subcommittee meeting we will review the ISW policy, ISW roll out package and suggested training effort for presentation at the two day regional in Hopewell, VA.

In closing, please inform your area members of the opportunities to serve at the regional H&I level. We need help responding to letters to inmates, developing and starting the ISW project and working on better ways to communicate with regional, state and federal agencies.

The only event we have coming up in the near future is the annual "Jump in the Lake" sponsored by the Find a New Way to Live home group on August 24th beginning at 1:00pm.
