#### Vice-Chair:

Hi Family,

Below is my report for January 2024.

As a follow up to the report that was provided to area in the December ASC, myself and others reached out to NA World Services for guidance/ input on how the broader fellowship is addressing the \$5000 limit on gross receipts.

On December 14th, I spoke to Steve R at NAWS. Steve advised me that about 95% of the fellowship is in the same situation that NDANA is presently in - that being that our gross receipts exceed \$5000 annual and is under \$50K annual. He mentioned that out of those areas that did form a 501C3, they have not been successful at maintaining the status, due to the higher level of commitment that is demanded by such a status. His feeling was that twelve step fellowships was not a priority for the IRS. He also clarified that our income from literature would not be considered income, as the area is simply organizing the purchase. Also NDANA ASC is paying shipping and handling costs - coming to a net loss for that service. While he was not in a position to provide advice, he didn't feel there would be much at risk if we were to continue as we presently are. Steve also mentioned that where areas and regions are getting themselves into legal trouble is the failure to capture and pay sales taxes on convention sales or merchandise sales. He stated that states and local governments are much more interested in capturing taxes from merchandise and event sales than they are with 7th tradition contributions.

Separately, Jeff H also reached out to Steve R via email. I have included this as an addendum to my report. [see attachment "Vice Chair addendum"] In short, the email states the same in much more detail.

So, what does this mean for NDANA? From an organizational perspective, we are not making any recommendations to change how we are structured. However, one of the primary drivers for us looking into this issue was the number of contracts that are in various individual names. The Chair and I talked over the phone in December and thought that it might be a good idea to have all contracts that the area engages in under the Chair's name. This would require some changes and clarifications to policy. Additionally, we would need to make some much needed maintenance changes - like getting the PO

Box out of the present individual's name and under the chairs. We can discuss more about this concept during open forum to get the groups thoughts before we proceed to any motions.
