Vice-Chair:

Good Afternoon Everyone,

Thank you for trusting me to support the efforts of our area groups to further their primary purpose and I look forward to the opportunity to serve. Since our last meeting, I have gotten the keys to the storage unit and the mailbox and checked the mail earlier today.

Following last month's Open Forum, I reached out to the Outreach chairperson and relayed the body's concern regarding the status of meetings that are not showing up to ASC and the considerable amount of interest that was expressed in regards to getting involved with the Outreach Subcommittee.

I have also revamped the ASC Meeting Attendance spreadsheet to make it easy to identify homegroups that have not attended ASC in the last 3 months as well as those that have either been absent or only reported at the last 3 meetings. I will be sharing this list with the Outreach chair each month and encouraging them and other members of the subcommittee to attend these meetings in person and report back to ASC regarding their status.

As of the November ASC...

- 13 meetings have not attended ASC in the last 3 months
- 13 additional meetings have either not attended or only reported at the last 3 meetings

In other words, the group conscience of 26 out of the 58 meetings in our Area have not been represented at ASC in the last 3 months, and last month 31 meetings were absent from ASC, the highest number of absentee groups since at least December 2023 (the earliest month for which I have data).

Given the large number of meetings on this list, contacting each group individually is likely to take a few months and I strongly encourage all of those with an interest, or those with sponsees in need of a service position, to get involved with Outreach.

So, to all of the GSRs here today, thank you for taking time out of your weekend and your willingness to serve. You are the vital link between your homegroup and the rest of the fellowship. For those that are voting, FANTASTIC, by representing your group conscience in matters affecting other groups and NA as a whole you give your homegroup members the opportunity to participate in the growth and development of NA at all levels. For those that are just planning on reporting today, thank you too, but please consider sticking around and voting your group conscience today and in the future to ensure this service committee remains directly responsible to **everyone** we service.

"Craig [R] will be bringing a money order in the amount of \$141 as a donation. These funds are the remaining balance from the Recovery Rockstar Homegroup, which closed on 9/13/25."

Treasurer:

Hi family,

Apologize that I am not able to attend Area today due to family Chanukah celebration. Scott and I continue to meet regularly and have scheduled our annual audit for January 4, 2026, time TBD. Our audit is required by policy 2 (k) which states that

"The NDANA ASC Executive Committee (Chair, Vice-Chair, Secretary, Treasurer and Vice Treasurer) members shall get together between the Dec ASC and the Feb. ASC and audit the NDANA Checking account. Then the Treasurer shall give a report at the Feb ASC with the results of the audit."

Note that this policy does not prohibit others from attending or participating in the audit, however requires the ASC Exec committee attendance.

Our end of month balance (Nov 30, 2025) was \$16,547.29. Our CARNA donation was not yet sent and will be part of December's expenses. That was my mistake as I had to leave a few minutes early from area last month and forgot to get the second signature on the check. Scott will ensure it gets signed today and mailed ASAP. The amount is \$200.40.

Our expenses last month totaled \$1337.19 with income of \$1672.84. We have no outstanding checks.

Ample Storage is due for renewal this month. As of yet I have not received any information indicating a price increase and therefore would recommend no changes to next year's Inventory Storage budget line.

Vice-Treasurer:

Hey Family,

Last month we, again, did not meet our donation target. As a reminder our monthly allocated budget is \$1366.67. Last month we brought in \$759.17. This is a shortage of \$607.50 and reflects the lowest level

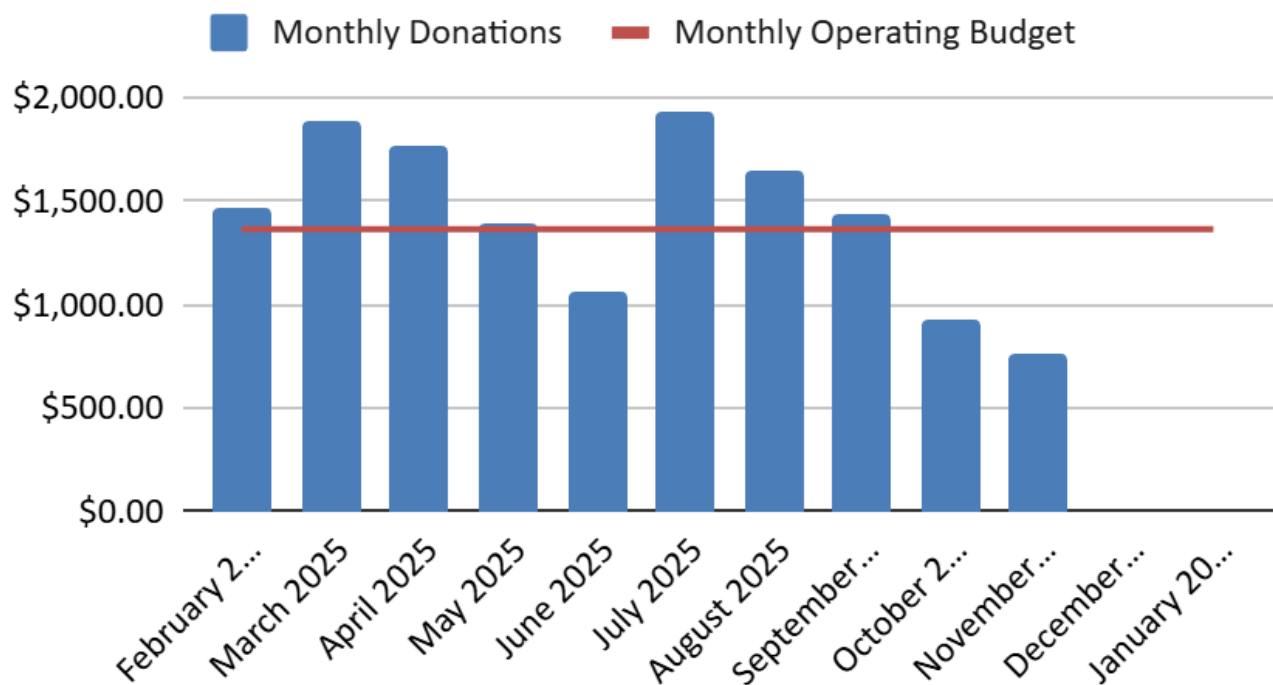
of donations we have received in at least the last two years. The attached graph shows the recorded donations versus allocated budget for this year. Over the last two months, we are \$1049.66 short of our allocated budgets which will be compounded further once the check for CARNA has been cashed.

Also, over the next month, the Treasurer, myself, and/or possibly other administrative committee members will be setting up meetings with each of the subcommittees to review budget information in anticipation of our annual audit and the setting of next year's area budget. These meetings are to help us to set accurate and appropriate budget allocations for each subcommittee and do not need to be super formal. Finally, elections for treasurer and vice treasurer are next month. If you have any interest in either position, please see me or Debbie ASAP. This position does involve the handling of money and utilization of basic accounting principles. VRCC Director:

Hey family,

Lots of information to report for VRCC Director. All is moving forward with the 42nd AVCNA. As reported last month- the hotel is on the pricier side- so if you are able to double up for the nights- I'd suggest doing so.

The VRCC meeting in November addressed finalizations made for the 42nd AVCNA with no major concerns. I was not in attendance due to illness, but VRCC Alt Director was.

The VRCC met on Monday December 8th at 7pm for an emergency directors meeting regarding the 43rd AVCNA and future moves within the VRCC.

The meeting focused on discussing and voting on one of three options: 1. the VRCC hosting the convention. 2. Rebooking it for 2027/2028 instead of 2026/2027 for a cost of \$2000 with minor increases or 3. cancelling it outright for a total of \$4289 cost. The board voted to push the 43rd AVCNA to 2027/2028 as the cost of negotiating a new agreement with Founder's Inn in VA Beach was deemed

to have the least financial impact to VRCC and give adequate planning and fundraising time for the convention and for a host to be secured (we currently still do not have a host). During this time it will allow the VRCC to continue to search for a Treasurer and an Accountant.

There was a treasurer voted in in October however, they resigned soon after.

There are several factors that caused this emergency meeting on December 8th and the motion that occurred.

1. Currently there is no host just a location for the 43rd AVCNA. As a reminder- any area can host, they just have to host at the locations secured within a rotation.
2. Due to financial concerns and that we would not be in compliance with the contract with the hotel, costing VRCC more if we did not reschedule.
3. Currently the VRCC has not filed taxes since 2020.
4. On advice from VRCC appointed attorney- he stated that it would be in our best interest to continue with the 42nd as planned but to "pause" for future convention.
5. Due to non-compliance with filing taxes- this does bring a concern of our non-profit status for tax exempt status moving forward.

I have only been in the ALT director position and now the Director position for around a year in total so without going back in reports- this is the most accurate and up to date information I have.

With all this said. I will continue to represent NDANA as VRCC Director through the 42nd AVNCA and until the position opens for election in February. At that time- I will not be accepting nominations to continue or pro-temp. I feel I have served this area in several service positions to the best of my abilities; However, I will not continue past my commitment end.

- *Scott M: Does that mean that the 43rd is just going to be the next year?*

- *Mackenzie: No, we followed the lawyer's advice and did pause. That's why it's pushed back a year. Anything could happen in that time, if we need to cancel then we can but for now we've just pushed it back in case we are able to proceed.*
- *Tayvon: So is there a story as to why we didn't pay?*
- *Mackenzie: Not that I've been made aware of.*
- *Richard S: So did we lose our non-profit status 6 years ago then?*
- *Mackenzie: Not yet, but we are currently still non-profit on paper. We could lose it but at this point we don't know.*
- *Richard S: Is there any concern with choosing locations with extreme political views, like Founder's Inn? [someone called this an outside issue and it went unanswered]*
- *Tina S: So I used to be VRCC secretary, and at one point we couldn't find the EIN. That was supposed to have been fixed.*
- *Mackenzie: As far as I'm aware, the EIN was located but no further action taken.*

- *Richard S: Each time that treasurer changes there's supposed to be paperwork to file and to get a new EIN, because it's attached to an individual.*
- *Bryan M: It was fixed when Kelly M was treasurer.*
- *John M: In the interest of time, I'd like to suggest that we move on and if anyone has further questions they can speak with VRCC Director offline.*

VRCC Alt. Director:

I am sorry to miss today (family illness). I'm looking forward to the AVCNA in January 2026. I attended the last regularly scheduled VRCC meeting (November) virtually and represented our area that day with our VRCC Director unavailable.

Reviewed Mackenzie's report today and her update covers everything.

Admittedly not sure I yet understand the issues in their entirety around VRCC being behind in taxes (history of this issue) and the possible implications, if any, to those in service positions. At our November 2025 meeting, some concerns (all listed in Mackenzie's report) were discussed and several trusted wanted us to start working with an accountant and an attorney. I will be interested to hear updates. Happy to be of service.

Outreach:

I want to start off by saying it's been an honor and a privilege to serve the New Dominion Area of Narcotics Anonymous. I would like to share my thoughts about my experiences thus far, how we can improve things, and the future of Outreach.

First, I want to remind everyone of what I said when I was nominated the first time and declined. My reason was I had no experience with Outreach. I did end up getting nominated again at that same Area and I, self-lessly accepted, with the best of intentions. I did read the Outreach handbook but I lacked a former experienced sub-committee chair or member to serve as a guide. Someone to share their experiences with Outreach so I didn't have to learn the hard way or fall short. In these short 5-6 months I have learned quite a lot and accomplished some of my goals. I teamed up with Literature and we had an amazing Open-discussion workshop. I also facilitated my first GSR workshop. I enjoyed both quite a bit. Since the GSR learning day I was starting the planning for the next one taking into account the things i fell short in and learned from with the last one. I learned to give the area adequate time to announce, a month and a half at least. I also learned physical flyers are worth the cost. Unfortunately, there is one lesson I had to learn the hard way recently, that I had not paid much mind to. I needed help. I needed sub-committee members. I can and could not do this alone. The groups' needs in this area far exceeds the resources Outreach can offer with just one person at the helm. I failed to see the importance of this all along. I could have done better or more. I could have held and announced consistent sub-committee meetings. I could have made flyers with links and info to help build the sub-committee. I could have solicited my vast network. I could have accepted help from others who did offer, but declined due to my greatest defect of character, self-reliance. Ultimately, I failed myself and I failed this Area due to my own ignorance. I swear, I did my best with the little that I did know about Outreach. The sincere truth is I'm human. I get tired. I get sick. I get overwhelmed. I get my priorities confused at times. I have learned even the best of intentions, I can do harm, in ways I never

imagined. I know going forward, there are many groups that need attention. We need to build this sub-committee. We have 31 meetings without representation at this moment. Craig, our new Vice-Chair has made a list of all those meetings. We don't know if they have or are using NA literature. We don't know if they have trusted servants to open doors, set up and chair the meetings. We don't know if they're adhering to the traditions. These are all big questions that can be answered by going to these meetings and filling out a visitation report to discuss in the sub-committee and bring back to Area. This will take a collaborative, strategic and methodical approach to address each group and their potential needs. Outreach's job is not to just attend meetings regularly, that needs the support of experienced members. It is also to support them by helping them help themselves as well. We can teach them how to get NA literature. We can teach them how to solicit additional support by announcing their meeting's needs at other meetings. We can encourage them to come to Area and do the same. In addition, as an Area we need to keep the "Get involved" tab in the RVANA.org site up to date. This must be a collective effort between the Web-servant and Outreach. Also, announcing one or two meetings that need support, by each member of the sub-committee, at their own regular meetings is a great start in the interim. We must keep in mind not to over announce too many meetings at one time. The sub-committee can divvy up the meetings to be announced. The meetings in New Dominion stretch far and wide. The more members on the sub-committee announcing those meetings, all over, the better. Signing up to be part of the Outreach sub-committee on a sign-up sheet is where it all starts. I believe in my heart it can be done. Outreach can thrive one day and the Area will thrive as a result. I say all this so that any future Outreach Chair doesn't fall into the same trap I Did.

With all that laid out, I am announcing that I am stepping down now as Outreach Chair. I choose my peace. Literature says, service is a posture of the heart. How can I serve whole heartedly when my heart is conflicted? I apologize, but I will not be taking any questions or comments. I am officially disengaging. It's been too much on me already. I wish the Area the best in its efforts.
