
Vice-Treasurer:

In December, we had \$1557.81 in donations which leaves us \$87.61 short of our operating budget for the month. We are now \$871.71 BELOW our operating budget for the year to date. As usual, I have included a pretty graph this month with my report to demonstrate that information.

As I have been reporting for the last few months, there will need to be some significant changes to budget allocations going forward if we are going to remain solvent. I have worked with the Treasurer to come up with a recommendation for the following year and it will be addressed as a motion in new business. I have also put together a print out that indicates more clearly the changes that we are proposing and the reasons for those changes. There are only 10 copies so please share them. Things are going well with Literature.

This past month, we had \$2,110.81 in literature orders between home groups and sub-committees. Several sub-committees and home groups have basic texts and Living Cleans on backorder. I will contact those groups as soon as the next literature order comes in. They may make arrangements to pick them up, or they will be delivered at Feb ASC.

There were two literature orders placed with world, totaling \$4,053.50. That included \$77.39 in shipping expenses, after discounts were applied. The committee also had \$67.28 of expenses in supplies. Accordingly, I'm submitting a request for reimbursement for \$4,120.78.

Per policy, I have provided the treasure and vice treasure our present inventory counts and values - which is presently at \$2,396.95.

Lastly, over the 2023-2026 conference cycle, there are four discussion topics out for fellowship input. One of which is "Gender-Neutral and Inclusive Language in NA Literature". I attended a workshop on this topic at the World Convention. I would like gauge level of interest from groups in attending in participating in a similar workshop here locally.
